



**MEMORANDUM OF AGREEMENT

Signed below, the Dean of Faculty of Economics and Business (FEB) of Universitas Muhammadiyah Sidoarjo (UMSIDA), the Director of Postgraduate of Universitas Muhammadiyah Sidoarjo (UMSIDA) and the Dean of Faculty of Business Administration of North Bangkok University (NBU) agree on this following Memorandum of Agreement (MoA) with this following agreements.

**CHAPTER 1
GENERAL POINT**

“The Collaboration Academic Exposure between UMSIDA and USIM” is the name of the program. The Faculty of Business Administration of NBU is the host of this program. This program will be initiated by conducting an international seminar and visiting lecturer at NBU on 18 of February 2017. As the host, The Faculty of Business Administration of NBU provides the venue and facilities during the program and agrees to give the necessary facilities for the coming related to it.

**CHAPTER 2
RIGHTS AND OBLIGATION**

The Faculty of Economics and Business, the Postgraduate of UMSIDA have obligated to:

- a. Pay the fees cost of organizing seminars and visiting professor / Doctor
- b. The students are obliged to attend the seminars and visiting professor / Doctor in accordance with a predetermined schedule
- c. The lecturers are obliged to give lectures according to the themes that have been agreed

The Faculty of Business Administration of NBU has the obligation to:

- a. provide the service and venue for the seminar.
- b. provide the materials used for the program conducted at NBU,
- c. and provide the certificate for the successful participants.

The Faculty of Business Administration of NBU has the rights to:

- a. get the documentation used during the program for academic and non-academic related publication,
- b. get the facilities as approved by both parties.

The Faculty of Economics and Business, the Postgraduate of UMSIDA has the rights to:

- a. get the documentation used during the program for academic and non-academic related publication,
- b. get the facilities as approved by both parties.

CHAPTER 3

COST

The Faculty of Economics and Business, the Postgraduate of UMSIDA have agreed to pay for the accommodation, service and certificates for the Program.

CHAPTER 4

TIME AND VENUE

The Collaboration Academic Exposure between UMSIDA and NBU will be conducted at NBU for one day at 18 February 2017.

CHAPTER 5
FORCE MAJEURE

Both parties agree that this agreement can be confined by possible forc e majeure such as earthquake, fire, natural disaster, demonstration and governments policy and regulation related to politics, economics, and law.

The either party who has the forc e majeure has to provide a written note to the other party as soon as one day after the events.

CHATER 6
ADDITIONAL INFORMATION

Any necessary matter which is not mentioned on this MoA will be discussed further using different letter as the part of this MoA. This MoA cannot be changed, added or modified with any mean unless there is a written agreement signed by both parties.


This MoA is written in English, and shall come into effect from the last date of signing. Each party shall retain one copy with both signatures.
